MINUTES OF THE MONTHLY DLOS' MEETING HELD ON THE 29TH OCTOBER, 2014 AT 12:00 NOON IN DC OFFICE/TAMENGLONG CHAIRED BY SHRI R.H.GONMEI, IAS, DEPUTY COMMISSIONER TAMENGLONG.

OFFICERS/MEMBERS PRESENT: (Attendance sheet attached as Annexure-1)

At the outset, Deputy Commissioner Tamenglong welcomed all the members present in the meeting. A brief introduction of the new Deputy Commissioner Tamenglong Shri R.H. Gonmei, IAS with the District Level Officers was followed by review of current issues which are noted in the meeting as follows:-

1. 11th STATE LEVEL ORANGE FESTIVAL: DC/Tamenglong apprised the DLOs on the upcoming 11th State Level Orange Festival, 2014 and he requested Shri Joseph Pauline, ADC/ADM, Tamenglong and Shri Kamiuthuan Kamei, Project Officer, DRDA Tamenglong to give more details on the festival. ADC said that as per the Orders of the Governor of Manipur the State Level Orange Festival will be celebrated every year on 9th December. The District Level Committee will propose the venue for the festival preferably at Tamenglong District headquarters which will be put up to the State Level Committee for approval.

Shri Kamiuthuan Kamei, Project Officer DRDA, Tamenglong apprised the members that this festival is being with two Committees, one at the State Level Committee with Hon'ble Deputy Chief Minister concerned Horticulture Minister as the Chairman alongwith other dignitaries/officers as members, and the other at the District Level with Deputy Commissioner as the Chairman alongwith other DLOs and other officers as its members. As the organisation of this State Level Orange Festival involves a huge financial budget for successful conduct, he further explained in detail how the fund was raised. The Festival which was organised in 2013 at Noney (Longmai) with a budget of Rs.48,25,000/- met some shortfalls/deficits. Apart from the donations received from generous donors which includes Chairman of District Council, SPD(SSA), Hort. & SC. Deptt., Tourism Deptt., PD (MACS), SMD (NRHM), Companies of N.F. Railways etc., the Hon'ble MLAs of the three Assembly constituencies have donated an amount of Rs.5 lakhs each in the previous years.

The State Level Committee meeting is to be held in the 1st week of November, 2014. Other important issues regarding the invitation to Chief Guest, VIPs, formation of sub-committees and detailed work allocations will be done in the subsequent meetings. All DLOs are requested to extend full cooperation for the successful conduct of the 1.1th State Level Orange Festival.

2. BHARAT SWAACHH MISSION/PHED: The EE/PHED Shri Poucharei Rongmei apprised the members that the ongoing Swachh Bharat Campaign will be

concluded on $31^{\rm st}$ October, 2014 and all the DLOs are requested to attend the programme at 10:00 a.m.

3. <u>HOUSE WARMING PARTY</u>: All the DLOs are requested to be present in the House-warming party at the DC's bungalow on 30th October, 2014 at 3:00 p.m.

4. CMO/MEDICAL: The CIMO Tamenglong Dr. Chambo Gonmei informed the meeting that Surgical Outreach Camp will be conducted on 7th November, 2014. Altogether there are 30 out of which, 3 sub-centres/PHSCs/PHCs are not functioning due to problems caused by illegal occupation of the buildings by the land-owners. The land-owners have been demanding settlement of the agreement made between them and the contractors by preventing the medical staff from taking over the buildings.

Additional Land for GNM Institute: Additional land acquisition for an area of 3.5 acres was proposed by the Health Department for the GNM institute at Duigailong village. DC instructed the concerned SDC Md. Imran Khan and CMO/Tamenglong and SDO/Tamenglong to coordinate on the matter at an early date.

5. KV/TAMENGLONG: The Principal of KV Tamenglong Shri MP Singh apprised the DC/Tamenglong on the issues regarding permanent site for KV School and estimates for repairing the temporary buildings. The KV Tamenglong is on the process to be closed down by the authorities by stopping intake of admission from Class 1 with effect from 2014 and will be so for the higher classes too in the coming years due to non-availability of a permanent site till today. Of the two alternatives sites the identified location at Khongjaron is most preferred from administrative point of view. However, the principal hinted that since this school is non-residential, the parents of the students preferred the other location which is near the Jail complex at Tamenglong Ward No.IV to which the DC/Tamenglong advised that with expansion of town area, growing number of taxi and bus services, security coverage from nearby 5 MR camp and availability of sufficient land the site at Khongjaron will suit best for permanent site of the Kendriya Vidyalaya, Tamenglong.

 PMEGP: The GM/DIC and Manager UBI/Tamenglong are advised by DC/Tamenglong to coordinate for resolving issues related to pending cases of loan to the selected PMEGP beneficiaries.

7. ENCROACHMENT CASES: Many Departments Viz: DEO (Employment), DAO (Agri), DIC etc. have reported encroachment of their compound by private individuals. On the statement of AAO (Agriculture) that staff of Revenue Department is colluding with the encroachers, DC clarified that the Revenue Department would not allow/endorse such unfounded practices in authenticity. The Departmental Officers are instructed to take care of their own compounds by making proper fencing and it is perceived that lack of fencing and caretaking by the concerned department is one of the reasons for encroachment. The minisecretariat Tamenglong which is constructed for all the Government departments could not be taken over till today due to lack of external water supply facilities in the buildings.
